All consignment wines being stored at THE CAVE are sold in "AS-IS" condition, and there is no guarantee of the consignment wines quality by THE CAVE and Consignor. Buyers are responsible for satisfying themselves concerning the condition of the wine. Buyers can ask for product checking or photo for reference before consumption.

交易安排 Transaction

- 買家提交訂購表格後，並不代表交易完成，本酒窖需知會賣家有關要求並需經賣家確認方可出售予買家。  
Transaction will not be completed for submitting this Wine Order Form. THE CAVE shall obtain Consignor's confirmation for selling after THE CAVE receipt this order.
- 賣家確認出售及將貨品交予本酒窖後，本酒窖會向買家發出發票，買家需於發票發出日 14 天內付款，否則賣家有權取消交易。  
After confirmation from Consignor on the sale of consignment wine, a Sale Invoice will be issued by THE CAVE to buyer. Consignor has the right to cancel the transaction if buyer fail to pay 14 days after the invoice date.
- 當確認收到款項後，本酒窖會向買家發出提貨通知。  
THE CAVE shall issue a Release Notice to buyer to collect the purchased wine after the exact payment has been affirmatively received.
- 如買家於收到提貨通知 14 日後仍未到本酒窖提取，本酒窖將收取每瓶每日港幣 2 元之儲存費。  
如於 90 日後仍未提取，本酒窖將保留酌情重新出售該貨品之權利，並自出售所得之淨額中扣除所有產生之費用。  
There will be a storage charge HK\$2 per bottle per day if buyer fail to collect the purchased wine 14 days after the Release Notice date  
And, if buyer fail to collect 90 days after Release Notice date, THE CAVE has the right to resell the wine and deduct all charges generate by this transaction.
- 買家需親自或委託第三者到酒窖驗貨及提貨，一經驗收及離開本酒窖後，所有貨品不得退回。  
Buyer should come to pick up the purchased by him/herself or by assigned third party.  
There will be no acceptance of purchased wine return once collected by the buyer from THE CAVE.
